# BOND

ourselves, our heirs, executors, administrators, successors, and assigns.

THE CONDITION OF THIS OBLIGATION IS SUCH, that whereas the aforesaid principal  
had applied to the City of Toledo for a license, which said license shall expire on the \_\_\_\_\_

Chapter 753, Toledo Municipal Code and in accordance with any and all amendments or  
supplements thereto, and rules and regulations promulgated thereunder.

Now, if the aforesaid Principal shall, during the life of said license, well, truly and  
faithfully observe and abide by all applicable ordinances of the City of Toledo and the aforesaid  
rules and regulations; and if the aforesaid Principle shall pay to the City of Toledo, and to all  
other persons entitled thereto, the cost and expense of removal and proper disposal of any  
waste collected by the applicant including restoration of property caused by the disposal of  
waste by applicant that in the judgment of the Director of Finance is not in compliance with the  
Municipal Code and/or not disposed of in strict compliance with all applicable existing  
ordinances, rules and regulations of the City, then this obligation shall be void, otherwise to  
remain in full force and effect.

The bond is executed pursuant to Chapter 753, Toledo Municipal Code, and is intended  
to comply with all requirements of said Chapter.

This bond shall be and remain in full force during the term of said license or permit  
unless cancelled in accordance with paragraph 2 below; but if said license or permit was issued  
for a term of one (1) year or any other specific term, and said license or permit is renewed for  
one or more specific terms, this bond shall be and is hereby extended to cover during such  
additional term or terms. In no event, however, shall the liability of the Surety be cumulative  
from year to year or from period to period, nor exceed the penal sum written in the first  
paragraph of this bond.

The Surety shall have the right to terminate its liability hereunder by notifying in writing  
via Certified Mail Return Receipt the Director of Finance, City of Toledo, One Government  
Center, Suite 2000, Toledo, Ohio 43604 thirty (30) days advance of its intention so to do.
