STEP 2. Multiply Step 1 by 2.25% (.0225) and write below.

STEP 3. Add up amounts in Box 19 of all your W-2's or W2-G's and write total below.

STEP 4. Deduct amount in Step 3 from the amount in Step 2 and write total below.

If the amount in Step 4 is less than \$10, do not remit that amount, but you must submit form. You will not be billed nor will that amount be collected from you.

If the amount in Step 4 is \$10 or greater, please submit payment with this return and check the Balance Due box at top of page.

If the amount in Step 4 is a negative amount of \$10 or more, you will receive a refund check from Toledo. Amounts of \$9.99 or less will not be refunded or credited. Also, check the Refund box at the top of the page.
